Two New Staff Members

J. Gudjonson introduced two new staff members from the TRU Office of Environment and Sustainability: James Gordon, Environmental Programs and Research Coordinator, who started Sept 3 and is replacing Kaitlin Boyd while she takes a year's leave to complete her Masters of Resource Management at SFU. Besides his duties with the TRUOES, he will be a resource person for this committee and will, among other tasks asked of him, send out EAC agendas, minutes and update the EAC website. He will receive the necessary training to update and maintain the EAC website.

Natalie Yao, Energy Specialist, who started last May, is focusing on issues to do with natural gas savings and efficiencies. As a result of Tom Owen's passing, Jim has been Interim Director since last April. How the Director's position will be filled will be determined in the next few months.

Plastic Beverage Container Review: The final version of the report was completed about a month ago by Jim and Kaitlin and passed on to the TRU Board of Governors for review at their upcoming September board meeting. The Board will discuss it and get back to Jim about next steps.

Tom Owen Memorial Scholarship – The goal is to raise \$20,000. Currently, the amount raised is \$4000 to \$5000. Proceeds of approximately \$150-\$300 from the latest Tom Owen Golf Tournament in August went into the fund. One idea to raise further funds is to raffle off the Giant electric bike that TRUOES purchased several years ago and has been sitting since. It's valued at \$2200. J. Gordon will investigate the raffle option.
